DETAILS:

- An announcement of the latest firmware release that provides updates to resolve previous issues.
- A good preventive maintenance practice keeping current available firmware version ensures optimal functionality

WHAT'S NEW IN THE RELEASE:

- New Automatic Reconnection feature. Enhance user connectivity experience when WM500 is used with Kodiak application. When the connection to the Kodiak application is interrupted/lost, WM500 automatically attempts to reconnect approximately every 5 seconds indefinitely to the application until successful reconnection to Kodiak application. In addition, pressing the PTT or Emergency button will trigger an immediate attempt to reconnect to the application. NOTE: The MFB and programmable buttons (P1-P4) will not function when the connection to the application is interrupted/lost; the functions of these buttons will resume after successful reconnection to the application.
- Support language selection (English, French and Dutch) via Accessory Manager. Require Accessory Manager App version 1.0.11 or later
- Support MXP600

HOW TO UPGRADE:

Connect and upgrade WM500 via Accessory Manager Application 1.0.11 or higher. Available on Google Play store.
